Not-for-profit status

CILC is a Dutch foundation and therefore not profitbut mission-driven. This allows us to combine performance and flexibility with full commitment to positive development outcomes and makes us more adaptable to building sustainable partnerships. CILC supports justice reform processes and facilitates international legal cooperation. We provide advisory and capacity building services to strengthen justice sector public authorities, professional associations, training institutes and justice reform task forces in developing countries and countries in transition.

The mission of CILC is to promote the rule of law worldwide by initiating and implementing international cooperation projects. We share the Netherlands' experience in the legal sector and create enduring partnerships between Dutch and partner countries' legal institutions and organisations.

CILC is a Dutch not for profit organisation, based in The Hague, and is a mandated body for the implementation of EU twinning projects on behalf of the Ministry of Security and Justice in the Netherlands.

We bridge demand and supply of capacity building for rule of law since 1985. Our experience spans the globe and all major thematic areas of the justice sector.

Our approach

We create frameworks for exchanging different experiences and tools, linking them with real problems, and building in feedback loops and accountable working methods in a local and regional context. On the basis of these practices and our comparative and practical knowledge of various systems, we develop together with our partners tailor-made solutions and subsequently help with their practical application.
