Detailed description of project						Type and scope of services provided		
<p>The objective of this EU funded Twinning project is to improve the enforcement procedures in Albania, in terms of the organisation of the judicial system and the bailiffs, as well as concerning legislation in force.</p> <p>The project has the purpose to simplify enforcement procedure, shorten the duration of enforcement procedure, reduce the courts' workload, reduce inflow of the enforcement cases to the courts and reduce enforcement cases backlogs in the courts.
